Prospective candidates and nominators should verify their financial status and any other qualifications required by the Organisation's rules prior to lodging nominations.

Nominations must reach the Returning Officer via the lodgement methods stipulated below **not later than 4:00pm Australian Eastern Standard Time (AEST) on Wednesday 24/05/2023.**
